

Regulations of the Gran Fondo Poznań event (hereinafter referred to as: "event")

I. ORGANIZER

- 1.1. The organizer of the Event is Sport Evolution Group Sp. z o.o., Jana Kochanowskiego 12/23, 01-864 Warszawa, registered in the District Court for the capital city of Warsaw, XIII Wydział Gospodarczy Krajowego Rejestru Sądowego, KRS 0000779253, NIP: 1231431002, REGON: 382960037, **address for correspondence ul. Janki, ul. Falencka 1B, 05-090 Raszyn**, (hereinafter referred to as the "Organizer").

II. DEFINITIONS

- 2.1. **Organizer** - the entity responsible for organising the event;
- 2.2. **Athlete** - a legal person who has registered for the Event by completing the registration form and paying the entry fee;
- 2.3. **Entry fee** - the fee that must be paid to register for the event;
- 2.4. **Resignation** - resignation from participation in the event, resignation means deleting the athlete from the list of event participants;
- 2.5. **Transfer** - transferring the entry fee to another athlete, transfer means deleting the athlete from the list of event participants;
- 2.6. **Starting Zone (Start)** - a designated area where athletes start participating in the event;
- 2.7. **Finish Zone (Finish)** - a separate area where athletes finish their participation in the event.
- 2.8. **Race Office** - a separate area where athletes collect items necessary to take part in the event;
- 2.9. **Event website** - the official website of the event, www.gfseries.pl.
- 2.10. **Extra Service** - an additional service purchased by the athlete, which is not included in the entry fee.

III. GENERAL RULES

- 3.1. Persons who have the status of amateurs, i.e. who do not have a licence of the Polish Cycling Union, can take part in the event. Persons with a licence of the Polish Cycling Union (Orlik U23 or Elite) will not be allowed to take part in the event.
- 3.2. In the event that an athlete holding an Orlik U23 or Elite license starts in the event, he/she will be disqualified.
- 3.3. The rules were developed on the basis of the guidelines of the Ministry of Culture and National Heritage, the Ministry of Development, the Sport and the Chief Sanitary Inspector. The rules apply to the organization of mass events during the SARS-Cov-2 virus pandemic and the and the Act of March 2, 2020 on special solutions related to the prevention counteraction and combating of COVID-19, other infectious diseases and crisis situations caused by them (Dz.U. z 2020 r. poz. 374). Each athlete undertakes to adhere strictly to the sanitary regime referred to in the preceding sentences.
- 3.4. Throughout the event, all athletes and supporters must comply with the current epidemic guidelines available at www.gov.pl.

- 3.5. While in the race office, a competitor is obliged to cover his/her mouth and nose with a mask.
- 3.6. In the starting zone the competitors are obliged to keep a social distance.
- 3.7. To reduce the risk of contracting Covid-19, we recommend that all people diagnosed with one of the following conditions: pregnancy, diabetes, high blood pressure, recent stroke, chronic lung or heart disease, chronic renal failure with dialysis, chronic liver disease with cirrhosis , decreased immune function did not participate in the event.
- 3.8. While staying at the event site and moving on the premises of the facility, athletes should comply with the applicable regulations, in particular ensuring social distancing and stay at a safe distance from each other, in accordance with the current guidelines of the Ministry of Health and the Chief Sanitary Inspector, WHO and law. The guidelines are available on the following pages:

- 3.9. It is forbidden to enter the event by persons staying in quarantine, under epidemiological supervision or showing signs of infection (fever, cough, shortness of breath).
- 3.10. Each athlete is required to complete a screening questionnaire, which will be included in the QR ticket.
- 3.11. The athlete declares that he is aware of the risk incurred when it comes to infection with the COVID - 19 virus during the event. He is aware that despite the implementation of a sanitary regime and compliance with appropriate procedures by the Organizer, there is a risk of infection.
- 3.12. The athlete declares that he has read the epidemic safety rules applicable during the event and undertakes to comply with them.
- 3.13. The athlete declares that he will not make any claims against the Organizer in the event of being infected with the COVID-19 virus during the event.
- 3.14. In case of cancellation due to COVID-19 pandemic, the Athlete agrees to receive a voucher, of the value of the entry fee paid, to use at the Event taking place in the Gran Fondo Series in Poland in the following year.
- 3.15. If the date of the Event is changed due to the COVID-19 pandemic, the athlete will be automatically transferred to the new date of the Event. The athlete will have the opportunity to change the entry fee into a voucher within the time specified by the Organizer. The voucher of the value of the paid entry fee will be available for the competitions taking place in the Gran Fondo Series in Poland in the following year.
- 3.16. In the event of cancellation or postponement of the event due to the COVID-19 pandemic, the money for the purchased additional services will be returned to the competitor within 180 days. Purchased insurance will not be refunded.

IV. DATE AND PLACE

- 4.1. The event will take place on 3th July 2022 in Poznań.
- 4.2. The Start and Finish shall be located at Poznań International Fair.
- 4.3. The start time of the event will be published in the "Program of the event" on the event website at a later date.

- 4.4. The start will be divided into time zones, separate for both distances. An athlete will be assigned to a zone according to his/her declared finishing time.

V. DISTANCE, ROUTE, TIME LIMIT

- 5.1. The Event will be held at the following distances:
 - 5.1.1. Gran Fondo - 106 km, time limit: 5 hours
 - 5.1.2. Medio Fondo - 65 km, time limit: 4 hours
- 5.2. The Organiser reserves that the final length of the routes of particular stages may slightly differ from the lengths given in points 5.1.1, 5.1.2. Permissible difference is +/- 5% for each stage and the exact length of the routes will be given after their final approval and will be included in GPX files of the routes made available by the Organiser.
- 5.3. To participate in the Event is allowed bikes are depending on selected distance:
 - 5.3.1. Gran Fondo - Road bikes, gravel bikes and cyclocross only
 - 5.3.2. Medio Fondo - all roadworthy technical bikes, except those described in point 5.4.
- 5.4. Triathlon bikes, time trial bikes, bikes with aerobars, tandems, recumbent bikes, bicycles and unicycles are not allowed during the Event.
- 5.5. The detailed route of the event will be published on the event website. The Organizer has the right to change the route and its distance. Such a change shall not give rise to any additional claims and obligations.
- 5.6. Apart from the Organizer, persons authorised by the Organizer and public services, no person without a start number is allowed on the route. Persons violating this prohibition may be removed from the route by appropriate services.
- 5.7. Electronic time control checkpoints will be located on the course of the Event. Omitting the control gate may result in disqualification.
- 5.8. Refreshing points will be located on the course of the Event.
- 5.9. After the limit expires, the athlete is obliged to immediately leave the race route.
- 5.10. A person who stays on the route after the time has expired, does so at his own risk and may be punished for breaking traffic regulations and the Civil Code.

VI. PARTICIPATION

- 6.1. A person of at least 18 years of age (persons born before 3th July 2004) may take part in the Event.
- 6.2. Each athlete who enters the Event must be verified at the race office. In case of purchasing the „Starting kit delivery" service, verification takes place at the time of collecting the starting kit, and the athlete does not have to appear for verification again at the race office.
- 6.3. Successful verification is conditional on:
 - 6.3.1. the athlete's personal appearance in the race office and submitting at the race office a confirmation of the entry in the form of a QR code to be downloaded from the received e-mail and an identity document or passport
 - 6.3.2. appearance of an authorised person in the race office, who shall be obliged to present a confirmation of the competitor's registration in the form of a QR code, an authorisation signed by the competitor and a photocopy or a photo of an identity document or a passport (to be provided)
 - 6.3.3. In the case of purchase of the „Starting Kit delivery" service, the Declaration is signed upon receipt of the starting kit, in the presence of the courier.

- 6.4. The QR ticket, necessary for verification at the race office, will be made available to the athlete no later than 3 days before the event to the e-mail address provided during registration.
- 6.5. The opening hours of the Race Office will be published in the Program of the event on the event website. The race office will be closed on the day of the event.
- 6.6. The cost of the entry fee, accommodation, travel and own meals are covered by the athlete on his own.
- 6.7. Athletes who take part in the Event under the influence of alcohol or drugs will be disqualified from the Event and will be suspended from the right to participate in the Event organized by the Sport Evolution Group Sp. z o. o. and related entities organizing sports events for 2 years.

VII. SAFETY

- 7.1. By stepping on the starting line the athlete acknowledges that he/she takes part entirely at his/her own risk, and in case of minors at the risk of their parents or legal guardians. The contestant, or parent or legal guardian in the case of minors, assumes the risk involved, acknowledging that participation in the competition involves considerable physical effort and entails the natural risk and danger of accidents, the possibility of personal injury and physical trauma (including death) as well as damage and loss of a property nature, and has voluntarily decided to assume this risk. The above does not exclude the organiser's liability resulting from mandatory legal regulations.
- 7.2. The organizer provides accident insurance to athletes who have been correctly verified in the Race Office. Each athlete will be covered by insurance cover in the field of accident insurance occurring during the insurer's liability period in the territory of the Republic of Poland, consisting in bodily injury or health disorder, causing permanent health impairment or death of the insured. The insurance is paid by the Policyholder, ie the Organizer.
- 7.3. The athletes are obliged to strictly follow the instructions of the Organizers, services responsible for road traffic management, including the Police, Municipal Police, judges and other services securing the route of the event.
- 7.4. The decisions of the medical service regarding the continuation of the race by athletes are final and indisputable. The medical transport of the athlete results in his disqualification.
- 7.5. If an athlete decides to withdraw from the competition at any time during the event, he/she must notify the judges or the organizer.

VIII. REGISTRATION

- 8.1. Registration for the Event will take place via the registration form available on SlotMarket.pl from 1st March 2022 to 24th June 2022 or until places are sold out.
- 8.2. The limit of athletes in the event is 1500 people. If the limit is reached, the Organizer reserves the right to close the registration earlier.
- 8.3. The Organizer reserves the right to invite people to take part in the Event after the limit of places has been reached or after the date given in point 8.1.
- 8.4. The organizer reserves the right to change the limit of places, and everyone who has purchased the package by the date of announcement of such a change has a guaranteed right to start.

- 8.5. The registration is considered when the application form is correctly completed and when the payment of the entry fee is paid in the amount specified in these regulations.
- 8.6. The confirmation of successful registration is:
 - 8.6.1. confirmation of registration for the event from SlotMarket.pl (confirmation from the email address contact@slotmarket.pl);
 - 8.6.2. payment confirmation from DotPay (confirmation from email address transakcje@dotpay.pl);
 - 8.6.3. information about registration in the Registration History on the SlotMarket.pl in user account (status: "Registered").

IX. GROUP REGISTRATION

- 9.1. Group registrations are accepted via the email address faktery@slotmarket.pl.
- 9.2. Payment for group entries is made to the Organizer's bank account on the basis of a Pro-Forma document with a 7-day payment deadline. Pro-Forma document is issued for the start of at least three participants (it is not possible to receive Pro-Forma for the start of a group of up to two people and for individual start).
- 9.3. Group registrations are accepted up to 30 days before closing the registration form.
- 9.4. In order to receive a Pro-Forma document, please send: invoice details and the number of participants to the address faktery@slotmarket.pl.
- 9.5. After making the payment for the Pro-Forma document, registration codes will be sent, reducing the entry fee.
- 9.6. Registration codes are valid for 14 days from the date of receipt of the codes.
- 9.7. People who register using codes are required to fill in the event registration form available on the SlotMarket.pl website and provide the code in the last step of registration.
- 9.8. People who do not register using the code, will not be allowed to take part in the Event.

X. ENTRY FEE

- 10.1. The entry fee for participation in the Event, depending on the order of payment and the type of entry fee:

- Tier 4 – 330,00 PLN
- Tier 5 – 350,00 PLN

- 10.2. In case the limit is not reached after 28 June, the organizer reserves the right to sell the starting fee in the Race Office on 2 July 2022. The entry fee in the Race Office is PLN 500.
- 10.3. The entry fee should be paid via the DotPay transaction service. All data provided in payments are entered on a secure encrypted page.
- 10.4. The fee must be paid upon registration, otherwise the application will be canceled.
- 10.5. The Entry Fee consists of servicing the athlete before the event (e-mail communication and via Social Media channels), maintaining the servers of the event website, purchases and renting products necessary to organize the event, as well as organizing and promoting the event.
- 10.6. An athlete who wants to receive an invoice for the paid entry fee should select the appropriate option in the registration form and enter the required data needed to issue the document. The invoice will be generated automatically after the payment is credited and will be available for download from the athlete's profile.
- 10.7. The organizer does not issue invoices in paper form.
- 10.8. If the athlete requests an invoice after payment, the invoice will be issued only for a legal person. The invoice may be requested by writing to the address faktury@slotmarket.pl until the end of the event.
- 10.9. Invoices to the individual will be issued up to three months after payment.

XI. STARTING KIT

- 11.1. As part of the event, each athlete receives:
 - 11.1.1. Bib number
 - 11.1.2. Wristband
 - 11.1.3. T-shirt
 - 11.1.4. Chip
 - 11.1.5. Food coin
- 11.2. Athletes who have completed the event are entitled to get a medal.
- 11.3. Persons who have purchased the PREMIUM entry fee will receive a T-shirt in the quality of Pro Tour T-shirts and will be able to collect their entry package faster at the Race Office.
- 11.4. The size of the T-shirt must be provided during registration. T-shirt size can be changed up to 2 months before the event.
- 11.5. The basis to receive the starting kit is scanning the QR code at the Race Office and verification of data on the basis of an identity document or passport.
- 11.6. Receiving the starting kit means that the volunteer will put on the athlete's wristband.
- 11.7. The location and opening hours of the Race Office will be given in the event program on the event Website. The race office will be closed on the day of the event.

- 11.8. The athlete is obliged to collect the starting kit himself.
- 11.9. The starting kits which will not be collected during the working hours of the Race Office may be delivered to the Athlete by courier on his/her request to the following address: contact@slotmarket.pl within 7 days from the day of the Event. The cost of delivery is:
 - 11.9.1. 50 PLN – Poland
 - 11.9.2. 25 EUR - European Union countries
 - 11.9.3. 70 EUR- countries outside the European Union
- 11.10. The cost of delivery is paid by the Athlete before delivery.

XII. EXTRA SERVICES

- 12.1. During registration for the event and after its completed, the athlete may purchase Extra Services.
- 12.2. The purchase of Extra Services is not obligatory and is not necessary to complete the race. The purchase of Extra Services is possible up to 7 days before the date of the race.
- 12.3. The price for the Extra Services is given in the event registration form on the Slotmarket.pl website.
- 12.4. Insurance and licence purchased from the Polish Triathlon Federation will not be refunded.
- 12.5. Insurance policies are purchased in Towarzystwo Ubezpieczeniowe TU Europa through the Slotmarket.pl portal. In this relation, the Organizer acts as an intermediary, not as an insurer.
- 12.6. When purchasing insurance, the Athlete accepts the General Insurance Conditions.
- 12.7. The Organizer is not responsible for the quality and timing of additional services. All complaints should be submitted to the entity providing the purchased service.
- 12.8. For the „Starting kit delivery" service, the terms and conditions of the service apply [Rules & regulations](#)

XIII. WITHDRAWALS & TRANSFERS

- 13.1. It is not possible to transfer an entry fee paid to another year.
- 13.2. Withdrawal from the Event shall be reported by [the form](#). The amount of the entry fee refund shall depend on the date of resignation:
 - 13.2.1. until 3rd April 2022 we refund: 50% of the entry fee;
 - 13.2.2. until 19th May 2022 we refund: 25% of the entry fee;
 - 13.2.3. from 20th May 2022, the entry fee is not returned.The above is due to the need to undertake and pay for activities to organise the Event.
- 13.3. It is possible to transfer the entry fee to another Gran Fondo Series event taking place in 2022
- 13.4. The transfer fee is PLN 39
- 13.5. In the event of transferring the entry fee to a Event where the entry fee is lower than the paid one, the difference in entry fees will not be refunded.
- 13.6. In the event of transferring the entry fee to a Event where the entry fee is higher than the fee paid, the difference in the price of the fees will be added to the registration.
- 13.7. The entry fee cannot be transferred to a sold-out event.

- 13.8. If you wish to transfer your entry fee to another event, you must do so by 19th June 2022
- 13.9. It is not possible to transfer the purchased additional services to other Professions. In the event of transferring the Professionals to other professions, the fee for additional services will be refunded.
- 13.10. Sponsorship, charity and other packages not covered by the starting fee are excluded from transfers.
- 13.11. The transfer can only be made once.
- 13.12. Events to be transferred must have open registration for at least 10 days from the date of submission of the transfer application.
- 13.13. In the event of using the option to transfer the entry fee, the Athlete resigns from the Resignation and Transfer Policy applicable to the Event to which the Athlete wishes to transfer.
- 13.14. The transfer of the starting fee to other Events should be reported via [the form](#).
- 13.15. A change of distance, within one event, is possible on 19th June 2022
- 13.16. Change of distance should be reported via [the form](#).
- 13.17. During registration for the Event, the Athlete has the option to take out additional insurance "Against the costs of resignation". The insurance is purchased through the Organizer via the Slotmarket.pl portal at the TU Europa Insurance Company
- 13.18. The Organizer gives the opportunity to transfer the entry fee to another person.
- 13.19. The transfer of the entry fee shall take place according to the Rules for the Transfer of Entry Fees [RULES](#)
- 13.20. It is possible to transfer the entry fee until 19th May 2022
- 13.21. Transferring the entry fee to another person is possible after paying a handling fee of 39 PLN. The handling fee shall be paid by a person registered for the Event via DotPay portal
- 13.22. A person who has received an email with a registration link is obliged to register for the Event within two days from receiving the email with the link
- 13.23. If a person who has received an email with a registration link does not complete the registration within the time stated in paragraph 13.7, the entry fee will be returned to the sales pool.
- 13.24. Once transferred, the entry fee is not transferable or refundable.

XIV. CLASSIFICATIONS & PRIZES

- 14.1. The following classifications will be conducted as part of the Event:

- 14.1.1. For Gran Fondo and Medio Fondo distances

- 14.1.1.1. An athlete who receives a prize in the general category may receive a prize in the age category.

14.1.1.2. Year of birth determines belonging to the age category.

14.1.2. The team classification will be conducted on the basis of the club name entered in the application form. The time of the top five people on each team, including one woman, will be taken into account

- 14.2. The official time of the Event is the gross time of the Athlete
- 14.3. The results will be announced no later than 15 minutes before the awards ceremony. The results will be hosted on the timekeeping company's website.
- 14.4. The results will be published on the Event website and reported to the media.
- 14.5. In the event of absence from the award ceremony, the prizes can only be collected at the Organizer's office up to 30 days after the end of the Event
- 14.6. The winners of places 1-3 in the age categories of women and men will receive commemorative statuettes.
- 14.7. The organizer reserves the right to introduce additional prizes in selected categories

XV. PROTECTION OF PERSONAL INFORMATION

- 15.1. Personal data controller of athletes is Sport Evolution Group Sp. z o.o., Jana Kochanowskiego street 12/23, 01-864 Warsaw, daneosobowe@sporteolution.pl.
- 15.2. Personal data of participants of Event will be processed for the purposes of organizing and carrying out Event, to select the winner and to award, release, receive the prize and other activities related to the economic activity and will not be shared with other customers.
- 15.3. For the purposes of chip timing and result sheet creation as well as sending one's bib number information and official time, personal data of the athlete (name, last name, year of birth, gender, city, email address, phone number) will be shared with Datasport, ul. Okrężna 22, 58-310 Szczawno Zdrój.
- 15.4. The participant has a right to access his/her data and correct them. Providing personal data and consent to their processing is optional, but necessary to achieve the said objectives. Failure to provide data or lack of consent to their processing prevents participation in the event. Please be advised that your consent may be revoked at any time.
- 15.5. Processing of participants data, in connection with participation in the event, includes publication of name, surname, year of birth, club participant with the name of the town in which he resides - in every way in which the project will be published.
- 15.6. All information concerning participants obtained by the Organizer and included in the registration form will be recorded in electronic way and in each case they will be used pursuant to in accordance with the applicable law.
- 15.7. The organizer reserves the right to carry out interviews with each of the participants, take photos and film them for advertising, promotional purposes, use on the Internet or in radio and TV broadcasts and for other commercial purposes.
- 15.8. The Organizer reserves the right to use, without compensation, all photographs, films, interviews, and voice recordings introducing the Event participants. These materials may be used by the Organizer in the form of CD-ROMs, DVDs, catalogues,

internet sites, newspapers, and exhibition stands, as well for promotional-commercial purposes concerning the Events run by the organizers.

- 15.9. The data retention period shall be
 - 15.9.1. For data processed for the purpose of asserting possible legal claims - until the claim is time-barred or the proceedings related to the claim are concluded.
 - 15.9.2. For data processed for the purpose of documenting and communicating activities, not more than 5 years from the date of the documented event, unless the data are processed for archiving purposes in the public interest.
 - 15.9.3. For data processed to ensure the security of networks and information systems - not more than 5 years from the date of registration.
 - 15.9.4. For data processed on the basis of the athlete's agreement - until that agreement is withdrawn.
- 15.10. In order to withdraw your consent to the processing of your personal data, you must complete the application form on <https://slotmarket.pl/document/polityka-prywatnosci> and send it to contact@slotmarket.pl.

XVI. COMPLAINTS

- 16.1. Complaints concerning matters related to the Event shall be submitted in writing with justification to the Organizer's correspondence address, with the note "Gran Fondo Poznań - Complaint", within 7 days from the date of the event - directly or by registered mail (the date of the postmark is decisive) or to the address: contact@slotmarket.pl, with the note "Gran Fondo Poznań - Complaint".
- 16.2. Complaints sent after the deadline in point 16.1. will not be considered.
- 16.3. Complaints about race will be considered by Organizer within 60 days of their receipt.
- 16.4. The Organizer's decision on complaints about race will be final.
- 16.5. The above does not limit the Consumer's rights to pursue their claims under mandatory provisions of law before common courts.

XVII. COMPLAINTS PROCEDURE

- 17.1. All Event participants are bound by these Regulations.
- 17.2. The Rules shall apply from the date of their publication i.e. 1st March 2022.
- 17.3. Each participant is obliged to read the regulations.
- 17.4. Ignorance of the Regulations does not release the athlete from the rules specified by the Organizer in these Regulations.
- 17.5. It is forbidden to bring any kind of narcotic, illegal substance, drugs improving athletic performance, as well as alcoholic products to the area encompassing the Event. Participants are prohibited from taking such drugs and substances both before and during the race, failure to abide by this rule may result in exclusion from participation in the Event. If it is found that an athlete violates the above prohibition, the organizer reserves the right not to allow him to participate in the race or exclude him during the race.

- 17.6. No Athlete may use measures or actions to increase efficiency. Athletes may be required to undergo tests before and after the Event. If the Athlete is called for inspection, he is required to report to the inspection.
- 17.7. Each participant who transfers and purchases a starting package without reporting this fact to the organizer may be disqualified as well as suspended from the right to participate in events organized by Sport Evolution Group Sp. z o. o. and related entities organizing sports events for 2 years.
- 17.8. On the reverse of the bib number there will be a table that each Athlete should fill in for easier identification in the event of an accident. The table contains data on medications taken, possible allergies and the telephone number of the person to be contacted by the Organizer in the event of an accident.
- 17.9. The organizer provides emergency medical care along the route and at the finish line.
- 17.10. The organizer provides a deposit. Valuables may not be left in the deposit, only things necessary to meet basic needs both before and after the Event. It is forbidden to deposit keys and access devices to cars and real estate, documents confirming identity, as well as cash and credit / debit cards.
- 17.11. The organizer is not responsible for items lost during the event.
- 17.12. The event will take place regardless of weather conditions
- 17.13. The binding and final interpretation of these Regulations shall be vested exclusively in the organizer of the Event. Should any of the provisions of the Regulations be partly or wholly deemed changed - all other provisions shall remain valid.
- 17.14. The organizer reserves the right to change the name of the event
- 17.15. The organizer reserves the right to cancel or modify the event for any reason.
- 17.16. In matters not covered by the regulations, the Organizer shall decide on the basis of the applicable law. The above does not limit the right to court in case of a dispute.
